Important Explanation :

In my earlier version 2 & 3, I had covered lot of questions of 'Decision Making' from the **old** syllabus of CA Final Costing. Because, I thought that the coverage of practical questions done by ICAI in their module is very low.

However, I got the feedback from lot of students that it is a wastage of their time and I should stick to the module of new syllabus only. These students also pointed out to me that the weightage given in the exam paper for 'Decision Making' chapter is low.

Based on this feedback, I had deleted some big size questions from my Version 4 notes and included more questions from new syllabus. However, while going through the new CSD (Jan. 22), I noticed that two of these questions from old syllabus are included again in CSD, with a slight modification.

It is really a **difficult** task for a faculty to cover **everything** which a student demands and which we think is **important** from the old syllabus and that too in a **short period** of time with **detailed** explanation. I think we need to learn magic tricks now.
